ONRC Call for Volunteer Board of Directors

On September 26, the ONRC members approved a new governance model that will lead the Society into an exciting future. As such, the ONRC Nominating Committee is reaching out to all SSVP Ontario members to consider running for one of nine positions on this new Board of Directors. We are seeking candidates from diverse geographic and cultural backgrounds. We are looking for people with experience and skillsets that they will put at the service of conferences and councils as they carry out the work of the Society spiritually and materially.

The initial board will be made up of staggered terms of 1, 2, 3, and 4 years. After this first cycle, terms will be four years. This allows for continuity of philosophy and planning in years to come.

The purpose for the ONRC is to promote and further the work of the International Confederation of the Society of Saint Vincent de Paul, throughout the province of Ontario and elsewhere in Canada when invited, in its mission "To live the Gospel message by serving Christ in the poor with love, respect, justice and joy."

Work of the Board is:

- To support that work through the conduct of research, education, conferences, and advocacy on the causes and determinants of poverty and hardship.
- To assist individual councils and conferences in their various charitable activities through the provision of financial, technological, legal and training resources and such other forms of support as they may require.
- To work and collaborate with other like-minded organizations on similar charitable activities for the benefit of those in need throughout the province of Ontario and elsewhere in Canada, when invited.

All Vincentians are eligible to apply and there is room for some non-Vincentians who have something valuable to offer. Please check out the website to see if you might be a candidate that can help lead the ONRC. We welcome all enquiries.

Stretch Forth Your Hand to the Poor - A Rural Response

In March of 2020, the world stopped just for a brief moment until everyone caught their breath and started to think. What can we do? How can we help? What are our next steps to continue our ministry as Vincentians?

Our Conference of Saint Vincent de Paul in the rural community of Strathroy started by putting one foot in front of the other and flying by the seat of our pants so to speak. Our comfortable routine of providing one meal a month was not possible since we used our parish center and that was suddenly locked to all traffic. All the other churches closed their doors. No one was feeding the poor. The only solution was a take-out bag lunch for the people we had been feeding all along.

We knew they were hungry and had no source of funds.

"What is suffering? Suffering is hungry, hungry for anything"¹. Hunger for food for the body and hunger for spiritual food for the soul. Surely the year of 2020 has pushed that thought to the limit and beyond.

Our President begged and proposed a Covid-19 safe plan to get access to the family center kitchen which has a direct route to the outside and thus started the course of action that we continue.

We could do it. Keep it simple. Keep it fresh.

Lunches were prepared on a weekly basis and they came. Those that needed food. Those that wanted to connect. Those that were bereft of funds.

A very valuable person joined our team of volunteers. Father Steve (then seminarian Steve) offered his help and came every week to greet the people, smile, chat and offer blessings to them. They looked forward to seeing him and our food for the body and the Soul was taking shape. He even drove meals and breakfast bags to a family 20 km away because he knew they needed help desperately.

People of the parish offered to make muffins and cookies, donated turkeys, and CWL ladies prepared breakfast bags for the children of those who came. A private donor gave enough money to buy 100 Mc-Donalds gift cards to provide an additional meal. Volunteer help has come from another church. In the words of a Mother/Daughter team who have provided delicious desserts, helped when we were short handed, and brought fresh produce from the farm, "We are all doing what Jesus told us to... He who has two coats, let him share with him who has none, and he who has food let him do likewise. Luke 3:11." The people that we are helping are not just our brothers in Christ, but our neighbours, someone who is struggling right down the street, or someone we see in our daily living. Rural help is special because what



comes from the hands of those giving is often used the same day, for example peas that were harvested that morning from the field were used in the stew that was being prepared.

Each week we look forward to meeting and having fun and feeding those that need our help. Rain or shine, hot or cold, we are there and so are the people.

> Our quest was not without conflict. Some members of the Conference felt strongly that another pathway should be followed, and this dissonance still exists. While we give out grocery cards for people to buy food, some had no place to prep it so no one method is enough. There must be more to meet the needs of those living in poverty. Our community is growing

and so is the population of those less fortunate who find the smaller community a safer haven than streets of the urban neighbor.

Our President is adamant that it is well past time to have a soup kitchen that functions 5 days a week. This is a massive project for a small conference as expertise in all aspects of making this happen are not readily available to us. Perhaps in the next 5 years it will become a reality.
